## SHERPA tool to characterise rural diversity

The SHERPA tool examines the characteristics of rural areas across Europe. To do this, it gathers data from different European databases and sources (i.e. Eurostat, Joint Research Council) and provides an immediate assessment of the selected territories by scoring their characteristics in terms of specific indicators.

As result, most of the value generated by the food supply chain does not go to farmers but rather to big companies. In Romania, 3 multiactor platforms point out what are the needs and gaps to tackle this issue.

## Remote territories shall be considered by EU policies

The EU Committee of the Regions adopted the opinion of Marie-Antoinette Maupertuis, President of the Corsica Regional Assembly on "Enhancing Cohesion Policy support for regions with geographic and demographic handicaps (Article 174 of the TFEU)". Through this option, the EU Committee of the Regions reaffirms its attention to remote rural areas, such as mountains, sparsely poulated areas, islands and cross-border regions.

What is a smart mountain? How to make territories attractive, resilient, and future-oriented? This was the focus of debates at the XII European Mountain Convention in Camigliatello Silano, Italy (October 2022), organised by Euromontana and CIA. The outputs of this event, summarised in the Sila Declaration, insists on the role of policies and research and innovation to support the development and future of unique and remote territories, such as mountains.

# Handbook of territorial and local development strategies


